#### **DECLARATION BY APPLICANT**

In making this application, I understand that:

- (i) If I am successful, FMC will use my Expedition to promote outdoor recreation.
- (ii) I will be expected to communicate my Expedition with others as outlined in the application form. Each expedition is required to provide a written report within 3 months of the completion of the expedition. The report must be accompanied with sufficient photographs for publication in FMC's Backcountry Magazine, Wilderlife blog or any other channels that FMC may wish to use. I confirm that any persons described in the report or depicted in the photographs consent for those reports, photographs and names to be used in any publication by FMC or 3rd party that is for the purpose of promoting the scholarships. For any drone footage, evidence of permission to operate the drone over the land (and/or people) depicted in the imagery must be provided to FMC on request.
- (iii) The Scholarship is to be used within one year of being received and cannot be used to undertake an expedition that is different from the one described on my application form.
- (iv) That if the above two points and other conditions specified in the Selection Criteria are not adhered to, then the award must be repaid to FMC in full on request.
- (v) FMC is not responsible or liable for any accidents, injury, illness or death should an unfortunate event occur during the Expedition.
